#### EMIGRANT SUPPORT GRANT

During the year the Department of Foreign Affairs of the Irish Government awarded a grant of \$7100 to the chamber which funds are used to build the capacity of the chamber to pursue it mission over the long term. Credit goes to pastpresident, Conor Barry who has retained this portfolio since stepping down as President. We are extremely grateful to the Irish Government for their generous support of the work we do. After a number of unsuccessful attempts over the years, the Ireland Canada Business Council was registered in 2022. It is headed by Jackie Gilna, who recently retired as President of the Ottawa chapter and I am acting as Treasurer. The ICBC brings together representatives from the five chambers across Canada (Montreal, Ottawa, Toronto Calgary and Vancouver) into a single organization which is empowered to speak for these chapters at a national level.

## **OP-ED DURING IRISH MONTH**

Last year we collaborated with Lydia Rogers of Enterprise Ireland (EI) in having an op-ed published in the Montreal Gazette. This is important exposure for the chamber and we intend to continue the practice to the extent that the Montreal print media is interested in publishing what we write. As well as EI, we can also collaborate with other partners such as IDA Ireland, Invest Northern Ireland, CanExport and Investissements Quebec. #### **BRINGING A CONSULATE TO MONTREAL**

First a tribute to the outgoing Honorary Consul General of Ireland to Montreal. During his more than twenty-year tenure in that position, Dr. Michael Kenneally has been a very close friend of the chamber and we have much to thank him for. I will ensure to have a more fulsome tribute penned in an upcoming edition of the newsletter. Thank you for everything, Michael and we wish you a happy retirement.

The question of whether Ireland should open a full consulate in Montreal has been close to mind since the Irish Government announced the opening of such consulates in Vancouver and Toronto. Ambassador McKee confronted us with the stark reality that the Irish Government has no plans to do anything equivalent in Quebec and encouraged us to launch a campaign to persuade those who decide these things that the status quo makes very little sense. After all, Quebec is the second province in Canada in terms of both population and wealth. Where it does lag behind, perhaps, is in the number of Irish natives making it their permanent or temporary home. If this were the only criterion in deciding whether it merits full-time diplomatic representation, the decision not to open a full consulate would be understandable. However, the trade benefits to Ireland of having diplomatic representation in Quebec are potentially enormous.

At the next board meeting in January we will discuss setting up a task force to lead the effort to have full-time Irish diplomatic representation in Montreal.
